

## ORDINANCE NO. 2-2025

### AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF HEDRICK, IOWA, BY ADDING A NEW SECTION FIREMAN PHYSICALS

**BE IT ENACTED** by the City Council of the City of Hedrick, Iowa:

**SECTION 1. NEW SECTION.** The Code of Ordinances of the City of Hedrick, Iowa, is amended by adding a new Section 35.02, entitled FIREMAN PHYSICALS, which is hereby adopted to read as follows:


**35.02 FIREMAN PHYSICALS.** The City will be responsible for the payment of any physicals needed for newly appointed volunteer fireman. The newly appointed volunteer fireman will need to retain volunteer fireman status for one year after completion of a physical. If volunteer fireman status is not retained and the fireman in question quits, resigns or is dismissed before the one year is completed, the cost of the physical will need to be reimbursed to the City by the volunteer fireman who received the physical.

**SECTION 2. REPEALER.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.


**SECTION 3. SEVERABILITY CLAUSE.** If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

**SECTION 4. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.

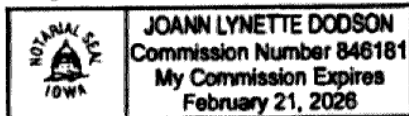
