YOU CAN VIEW THESE NEW POLICIES ON OUR WEBSITE AT www.hedrickiowa.com OR AT CITY HALL. ONE OF THE BIG CHANGES WE HAVE MADE, IS THAT THERE WILL NO LONGER BE PAYMENT EXTENSIONS GIVEN FOR UTILITY BILLS. ALL PAYMENTS WILL NEED TO BE RECEIVED BY THE DUE DATE ON THE UTILITY BILL OR BY THE DATE GIVEN ON THE SHUT OFF NOTICES. ALL PAYMENT PLANS CURRENTLY AGREED TO WILL BE HONORED.

- 3-2-13 (c) MOWING OF PROPERTIES. Any property within the City of Hedrick, Iowa, whether vacated or non-vacated, is required to be mowed any time the vegetation reaches a height of more than eight inches or more by April 15, May 15, June 15, July 15, August 15, September 15 and October 15 of each year.
- 3-2-13 (d) PENALTY. Any property, which is not mowed after the vegetation reaches a height of eight inches or more by the above dates, may be mowed by the City or their agents, and a minimum charge of \$75. plus an additional charge of \$75. per hour after the first hour for each such mowing, plus a surcharge of \$100. will be charged to the property owner. Any property owners who do not mow their properties, thus allowing the same to be mowed by the City or their agents, and who do not provide payment for the mowing as required, will be assessed by the City for such costs, which will be collected in the same manner as general property taxes. This fee schedule shall be reviewed annually to ensure that all costs are being recovered. If adjustments are required, the City Council may establish a new fee schedule by resolution.
